Parent volunteers will be utilized the same as in previous parties and the Sign Up Genius will be in the Mustang Minute on Monday, Jan 23rd.

Looking ahead we have our new Kindess Project which will run in the month of February. Yearbook is focused on layout and will be doing club/group photos as well as specials and some fun recess photos in the snow. School supply committee has begun compiling lists for the 2023/24 school year and will continue to work with grade level staff to finalize lists and pricing via our vendor. Rethinking Recess presentation

Mrs Salness shared information regarding a new Playworks Pilot that will rollout to Mill Street in the Spring. Tentative launch is right after Spring Break. This new pilot will offer a daily option of a structured activity (soccer, football, gaga ball, etc) by a staff member. This option will offer a team activity for those that decide they would like to play it. Non-structured free play will always remain an option for all students. Mill Street is excited to have the Playworks team join Mill Street to coach and guide staff and administration on how to better execute recess, and what suggestions they might have for us to enhance our recess period. Also, the large playground will be replaced over the summer after Summer School has ended. Student Council will get the opinions of students and they will vote on which playground will be installed. There are 2 equally exciting options and we are excited for this new format for our students. This playground will not be mulched, rather a soft surface similar to Nike Park to allow all students to have accessibility.
